Whereas, the Commissioner and Director of Municipal Administration, Andhra Pradesh, Hyderabad, in the letter 3<sup>rd</sup> read above, has submitted the proposals for constitution of Ramagundam Municipality as Municipal Corporation as it satisfied the criteria fixed in the Andhra Pradesh Municipal Corporations (Fixation of Criteria for Specification of Larger Urban Areas) Rules, 1994 issued in G.O.Ms.No.571, MA&UD (Elec-II) Department, dated.14.09.2009.

2. And whereas the Municipal Council, Ramagundam Municipality, in its resolution No.226 dated.29.11.2008, has resolved to constitute Ramagundam Municipality as Ramagundam Municipal Corporation.

3. Now, therefore, the Government, after careful examination of the matter decided to specify the areas covered under the Ramagundam Municipality as 'Larger Urban Area' under clause (d) of section 2 of the Andhra Pradesh Municipal Corporations Act, 1994.

4. The appended Notification will be published in an Extra-ordinary issue of the Andhra Pradesh Gazette dated 26.02.2010.

5. The Commissioner of Printing, Stationary and Stores Purchase (printing wing) is requested to furnish **100 copies** of the Gazette containing the Notification to the Government.
